Tonnage Tax Companies

Owners of Ships under Foreign Flag, Charterers and Ship Managers operating in the Republic of Cyprus

Subject: Cyprus Tonnage Tax System (Law 44(I)/2010 as amended): Non- Community Flags which appear on the Grey List and Black List of the Paris MOU for the Fiscal Year 2023

In accordance with the provisions of sections 17, 27 and 40 of Law 44(I)/2010 as amended, qualifying **non-Community ships** shall have their annual tonnage tax increased:

- (a) by thirty per cent (30%) if the flag they are entitled to fly appears in the Grey List of the Paris MOU (Annex I);
- (b) by sixty per cent (60%) if the flag they are entitled to fly appears in the Black List of the Paris MOU (Annex II).

It is also noted that ships (Community and non-Community) under management, flying a flag which appears in the Black List of the Paris MOU and do not fulfil the requirements of section 34(4) of the Law (i.e., the technical and crew management of such ships is not <u>entirely</u> performed from the territory of any EU/EEA Member State), shall be subject to additional administrative penalty, in accordance with section 54 and PI 559/2020.
